1. I understand the nature of Judo activities and believe I am qualified to participate in such Activity. I also understand the rules governing the sport of Judo.

2. I further acknowledge that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.

3. I acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, illness or disease, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. ### **RANK PROMOTIONAL TOURNAMENT GENERAL RULES AND INFORMATION October 14, 2017**

**ELIGIBILITY:** Open to any senior player holding a senior rank and is a currently registered member of Hudson Judo Yudanshakai. (Men's, Women's, and Masters) **ALL COMPETITORS MUST HAVE IN THEIR POSSESSION A CURRENT HUDSON/U.S. JUDO FEDERATION CARD. NO OTHER MEMBERSHIPS WILL BE ACCEPTED.**

Rules: Current IJF Rules with the following modifications:

- a) Competition time  
3 min. Round robin in all divisions
- b) Mat Size - 4 mats  
8m X 8m playing area with 4m safety between each mat and on the outside
- c) All contestants must wear a White Gi in order to be allowed to compete in this competition. **No Blue Gi's will be permitted.**
- d) There will be **no Kansetsu-Waza** allowed in the **Novice Division** or for players in the **15 to 17 year old** division.
- e) Care system will not be in use in this competition.
- f) Some rank divisions maybe combined depending on the amount of players available.
- g) All matches will be contested in round robin divisions.
